#### REPORT OF THE POLICE

Swatara Township Lieutenant Dennis Krahling stated 94 calls for service were placed for Paxtang Borough. Ten traffic citations, 6 motor vehicle code violation warnings, 17 parking violations and 3 foot patrols were carried out.

## **MOTOR CARRIER SAFETY ASSISTANCE PROGRAM (MCSAP)**

The MCSAP commercial driver vehicle inspection program is ongoing with inspections of commercial vehicles.

#### **CANINE REPORT**

The canine unit carried out vehicle searches, commercial/residential searches, 2 article searches, suspect trackings, apprehended 2 individuals, and attended 1 community service event. The newest member of the Canine Unit, Tattoo, has been assigned to work with School Resource Officer Ben Stewart. Tattoo's duties will include public events, community outreach, criminal investigations, visits to medical facilities, and non-profit community programs that address effects of trauma, mental health, and crime.

#### REPORT OF THE FIRE CHIEF

President Bloss stated 24 calls for service were placed with 3 being in the Borough. The Rescue ran 13 calls, Engine 9, Utility 1, Officer In Charge 0, and Fire Police 0. Borough calls were 1 unattended cooking, 1 minor vehicle accident, and 1 medical assist. Training consisted of monthly maintenance and RIT/SCUBA. Two members are taking HAZMAT Operations in preparation for their Firefighter 1 Certification and the Engine received 4 new rear dual tires.

#### REPORT OF THE ENGINEER

Engineer Smith informed Council that PennDOT is requiring a Traffic Signal Maintenance Agreement be signed before any new or revised signal permits are issued. The Borough is being asked to sign the agreement due to signal upgrades at 29<sup>th</sup> and Derry Street. Engineer Smith recommended signing the Agreement. ## TRAFFIC STUDY 29<sup>TH</sup> AND GREENWOOD STREETS

Councilman Wingert asked that a traffic study be conducted westbound at the intersection of 29<sup>th</sup> and Greenwood Streets. Study would focus on vegetation and vehicles in this area possibly compromising site distance.

*Property and Recreation* – Vice-President Spackman presented a draft copy of a Building Rental Cleaning Checklist. Vice-President Spackman suggested implementing the policy, reopening the gymnasium to rentals, and adding if cleaning regulations were not followed, a possible loss in rental privileges would be considered.

## **USE OF PAVILION**

Vice-President Spackman will present for Council's consideration the follow requests for gratis use of the pavilion under New Business: Local Girls Scouts, Paxtang Elementary School, Paxtang Lions Club, and Paxton Presbyterian Church

*Public Relations* – Councilman Martin reported that the latest edition of the Paxtang Post is out for delivery by the United States Postal system. A trash and recycling collection calendar has been mailed to property owners as well.
