*2) Councilman Gui made a motion to approve the Report of the Treasurer for the month ending August 31, 2019. Motion seconded by Councilman Thomas. Motion carried.

POLICE REPORT

Swatara Township Police Lieutenant Timothy Shatto stated 108 calls for service were placed for Paxtang for the month of September. Seven traffic citations, 16 traffic warnings, 4 parking violations, 1 enforcement detail, 11 foot/bicycle patrols, and mobile patrol details in response to drug related intelligence received through various methods were carried out. Sixteen youth graduated from the Swatara Youth Police Program. The program focused

on various aspects of law enforcement. Swatara Township Police Department's Car Seat Install/Check Program has officers certified to install vehicle child car seats. Installations and safety checks are by appointment. The Teaching, Educating, and Mentoring program (T.E.A.M.) is a program where officers act in a liaison role with schools to establish relationship with the students through teaching and mentoring. Corporal Timothy Bloss is the T.E.A.M. contact for the Paxtang Elementary School. Canine Officers J.T. and Kix performed multiple drug searches, patrols and apprehensions. Coffee with a Cop will take place at the Red Lion Hotel located at 4751 Lindle Road, Harrisburg on September 19. This event allows citizens to meet with officers in a causal setting to discuss community matters of interest. Councilman Wingert requested a follow up to a recent vehicular incident on 30th Street.

REPORT OF THE FIRE CHIEF

Deputy Fire Chief John Tinari said the Fire Company ran a total of 28 calls for service, 4 being in the Borough with a total manpower of 115. The average crew for the month was 4. Total hours in service was 6 hours and 33 minutes for a year to date total of 1,113.24. The Engine ran 26 calls, Utility 0, Officer In Charge 0, and Fire Police 1. Calls in the Borough were 1 vehicle accident 2 fire alarms, and 1 Harrisburg City call inadvertently dispatched to Paxtang. One training was held on Pump Operations. Top five responders were Chief Zwigart at 20, Firefighter Clark at 16, Firefighter Schaeffer at 15, Deputy Chief Tinari at 12, Lieutenant Lemmon at 12. The Rescue is expected to be back in service shortly. Repairs were authorized by Council at the August 2019 Regular Business Meeting.

CRABFEST FUNDRAISER

The 2019 Crabfest fundraiser to be held on Saturday, September 21 at Cibort Park in Steelton has been declared SOLD OUT.

FIRE PREVENTION OPEN HOUSE

Fire Prevention is the week of October 6 with Open House taking place on Wednesday, October 9 from 6:00 p.m. to 9:00 p.m. at the Borough fire station. Members will be making safety presentations at the Paxtang Elementary School and the Paxton Presbyterian Church on October 8 and October 9.

DERRY STREET SANITARY SEWER REPLACEMENT PROJECT

Ankiewicz Enterprises has reseeded the area as it was lacking acceptable grass cover. Project was awarded to Ankiewicz Enterprises at the May 20198 Regular Business Meeting.

MILL AND OVERLAY PROJECT

The mill and overlay project has been completed. A final walkthrough was carried out by Borough Public Works employees and Engineer Smith. All repairs and work items have been completed by E. K. Services. Project was awarded to EK Services at the July 2019 Regular Business Meeting.

*4) Councilman Thomas made a motion for PPL to install lights on utility poles at Sharon and Elm Streets and Apply and Swan Streets. Motion seconded by Councilman Gui. Councilman Thomas asked if the lights to be installed would be light emitting diode (LED) lights. Manager Stambaugh will research. After discussion, motion carried.

REQUEST FOR USE OF MUNICIPAL GYMNASIUM – FREEDOM GUARD

- *5) Councilman Thomas made a motion authorizing use of the gymnasium by Freedom Guard at a discounted rate. Motion seconded by Councilman Wingert. After a discussion on usage fees, Councilman Thomas amended his motion on the floor.
- *6) Councilman Thomas made a motion that Council allow Freedom Guard use of the gymnasium at a rate of \$25.00 per session between the dates of September 29, 2019 and April 19, 2020 on Sundays, 1:00 p.m. to 3:30 p.m. when available. Motion seconded by Councilman Gui. Motion carried.

REQUEST FOR USE OF MUNICIPAL GYMNASIUM - ST. CATHERINE CHURCH

*7) Councilman Wingert made a motion authorizing use of the gymnasium by St. Catherine LaBoure Church located at 4000 Derry Street, Swatara Township for their athletic association basketball ages 9 through 14 at the rate of \$25.00 per session on Monday evenings when available. Motion seconded by Councilman Gui. Motion carried.

BOROUGH SIDEWALK AND CURB REPLACEMENT – DAUPHIN COUNTY POLLING VENUE AUDIT

*8) Councilman Wingert made a motion to review quotes for replacing the sidewalk and ramps alongside gymnasium for compliance with the recent Dauphin County wide Americans With Disabilities Act audit of election polling places for an amount not to exceed \$6,500.00. Motion seconded by Councilman Gui. Councilman Eisner asked Manager Stambaugh to research the possibility of grant monies for this project. Deadline for completion is prior to the April 2020 election. After discussion, motion carried.
